Matt Connley – Bolsover District Council, stated that 6 tenders had been received for the project that were all within budget. All tenders had undergone a scoring process with himself, Cllr Gilbody, and Cllr Beckett. Hags UK scored the highest, with an amendment to be requested to lower the age group for the multi-unit. Hags UK included within their tender to repaint the existing swing, repair the wet pour areas affected by the installation, and to replace the park gate and path to the playground.

It was moved by Cllr Beckett, seconded by Cllr Kingscott, and **resolved** unanimously to accept the tender from Hags UK.

It was moved by Cllr Beckett, seconded by Cllr Wood, and **resolved** unanimously to remove standing orders to enable a member of the public representing Tibshelf Football Club to speak. The representative apologised that the lawn mowers had been left in the shower area - they were awaiting collection and the storage container will be painted as soon as the weather improves.
