

Minutes of the meeting of the Events Committee of Tibshelf Parish Council held on Tuesday 10th December 2024 at 7.00pm in Tibshelf Village Hall

EC061 To receive apologies for absence.

Apologies received from Cllr Ward and Cllr Kingscott.

EC064 Public Speaking

D Gibb said she had received comments that the hall didn't feel very festive for the Christmas light switch on event.

EC065 Confidential items

EC066 To approve the draft minutes of the Events Committee Meeting held 26th November 2024.

It was moved by Cllr Beckett, seconded by Cllr Wood, and RESOLVED unanimously to accept the minutes as an accurate record.

EC067 To consider an event to celebrate the 80th Anniversary of VE Day, including a date and associated costings.

It was moved by Cllr Beckett, seconded by Cllr Gilbody and RESOLVED unanimously to remove standing orders to allow a representative of Dance Tibshelf to speak.

Dance Tibshelf have enquired about booking The Daisy Belles to perform on Friday 9th May or Sunday 11th May 2025 (their preference is Friday 9th May) and asked if the Parish Council would consider a joint event whereby Tibshelf Dance paid The Daisy Belles booking fee and the Parish Council provided free hire of the village hall.

The PC discussed the option of organising a more inclusive event for all members of the village.

It was moved by Cllr Gilbody, seconded by Cllr Beckett and RESOLVED unanimously that the Parish Council holds a separate event.

The Clerk asked Dance Tibshelf to make a request for free hire of the hall to be considered at the next Village Hall Management Committee meeting.

It was moved by Cllr Beckett, seconded by Cllr Varney, and RESOLVED unanimously to hold an event to celebrate the 80th Anniversary of VE Day on Sunday 4th May 2025 comprising of an afternoon tea with entertainment, and an evening family 80's themed disco.

The Clerk and Cllr Gilbody to look into entertainment availability for the afternoon tea.

EC068 To review the firework display event and consider the 2025 event details, date, and associated costings.

It was moved by Cllr Varney, seconded by Cllr Beckett and RESOLVED unanimously to hold the event on either Saturday the 1st November 2025 or Friday 7th November 2025 at 6pm.

It was agreed to place this on the next Events Committee agenda for further discussion.

EC069 To reconsider the date of the 5th July 2025 for the carnival.

It was moved by Cllr Gilbody, seconded by Cllr Wood and RESOLVED unanimously to move the date to the 21st June 2025.

EC070 To consider events for the 2025 carnival and associated costings.

It was moved by Cllr Gilbody, seconded by Cllr Beckett and RESOLVED unanimously to allow a member of the public to participate in this item.

Fairground rides were discussed, and the Clerk informed the committee that the trees overhanging the track used by the fair to access the sports ground have a TPO on them, and a planning application would need to be made to BDC for any works requested with a supporting Arborist report.

It was agreed to recommend to Full Council to rebrand the parish carnival as a music festival/party in the park type of event, with live music, food, a bar and stalls. To run from 2pm to 9pm.
